REQUIREMENTS FOR THE DESIGN OF THE THESES:

1. The volume of abstracts - up to 3 pages (format - page A4)
2. Fields: upper, lower, left, right - 2 cm. Paragraph indent 1.25 cm.
3. The output and the main text of the abstract should be in the font: Times New Roman, 14 pt., line spacing - 1.0.
4. **The UDC (in bold)** is placed in the left corner of the sheet.
5. The next line contains the *Author's name (s) in bold, italics* in the upper right half of the page. Below (on the right) in the usual font in the following order: the first line - scientific degree, academic title; the second line - position in full with the name of the department; the third line – the name of the institution; the fourth line - the name of the city, country. Below through the line must be **TITLES OF ABSTRACTS**, capital letters, bold, centered.
6. Formulas should be executed in the formula editor, the drawings are grouped.
7. The title «**Literature**»: - center, in usual letters, bold, Times New Roman, 12 pt. The list of references is made out in the font: Times New Roman, 12 pt., line spacing - 1.0, numbered list, indentation 1.0 cm. Literature for abstracts submitted in Ukrainian and Russian languages is made according to the rules of the standards of Ukraine (State standard of Ukraine 8302:2015). References for abstracts submitted in English are made according to the requirements of the standard **APA** (American Psychological Association (APA) Style). Recommendations for link design:

8. Postgraduate and master's theses can be submitted both individually and in co-authorship with the scientific supervisor. Theses of the bachelor's degree holders are submitted in co-authorship with the supervisor.
9. Number of authors - no more than two persons.
The name of the abstract and application files must include the name of the *first* author and the number of the section (for example, Ivanov_1_abstract; Ivanov_1_application).
